RESIDUALS AND IMPURITIES NOTES: Residuals are tested by UL environment on a quarterly basis and Greenguard Gold certificate is achieved for Total VOC on all Formica Grades including Compact.

OTHER PRODUCT NOTES: Formica HPL are layers of paper saturated with phenolic resins for the core and melamine resins for the surface décor sheets. They are pressed under high pressure and 300 deg F temperatures. The monomers and polymers react under these conditions thus polymerizing into a thermoset hard resin system. The residuals are a very small fraction of the unreacted monomers and are less than 7.3 parts per billion under the Greenguard test protocol.mentioned in this HPD.
